I. AUTHORITY

Authority: Idaho Code § 67-833

II. ABSTRACT

The purpose of this guideline is to ensure logical and consistent presentation of web-based materials and services while conforming to federal guidelines for accessibility by users with disabilities. The requirements of this guideline apply to all public-facing web pages registered under the idaho.gov domain.

IV. HOSTING AND DEVELOPMENT GUIDELINES

A. Non-E-commerce Hosting

State agencies may choose from any of the following options for the physical placement of standard (non-E-commerce) websites and web applications. An agency may:

- 1. Use the centralized hosting services that the Office of Information Technology Services (ITS) provides.
- 2. Contract with another State of Idaho agency for the hosting services;
- 3. Setup, install, and maintain its own web server(s) for the hosting services; or,
- 4. Contact ITS for the current list of State-approved vendors to provide hosting services.

B. <u>E-commerce Hosting</u>

State agencies may choose from any of the following options for physical placement of E-commerce web applications. E-commerce web applications are those that involve the collection of credit card types of information and/or the actual electronic transfer of monies and/or funds. An agency may:

- 1. Setup, install, and maintain its own Internet web server(s) for the hosting of its PCI-compliant E-commerce web applications; or,
- 2. Contact ITS for the current list of State-approved PCI-compliant E-commerce vendors, and contract with one or more of those vendor(s) for the hosting of its E-commerce web applications.
- C. <u>Web Page, Website, and Web Application Development</u> State of Idaho agencies have the following options for the development of Internet web pages, websites, and/or web application development. An agency may:
 - 1. For new or replacement websites or web application development, submit an ITS Website Services Request on the ITS website;
 - 2. For minor website or web application requests, submit a Website Request catalog item in the <u>ITS Service Desk system;</u>
 - 3. Use its own in-house personnel for web page, website, and/or web application development;
 - 4. Contract with another State of Idaho agency for web page, website, and/or web application development; or
 - 5. Contract with a State-approved vendor to provide web page, website, web application, web development, and/or web maintenance. Contact ITS for a current State-approved vendor list.
