**WELCOME**

Chair Robertson welcomed everyone and called the meeting to order at 9:30 am MST. Chair Robertson is in receipt of proxies (attached as Appendix A) for Mike Woodford and Betty Conces. Roll call attendance taken, and a quorum established.

**MINUTES**

**MOTION: Mr. Weber moved, and Ms. Andersen seconded a motion to approve the minutes of the January 21, 2021 Meeting, as presented; the motion passed unanimously.**

**FEDERAL SEAT NOMINATION**

Chair Robertson called for a motion to nominate Eric Buehler for an interim appointment to the Federal seat on the Idaho Geospatial Council-Executive Committee (IGC-EC).

**MOTION: Mr. Weber moved, and Ms. Ames seconded the motion to nominate Eric Buehler to fill the vacant Federal seat (Seat 3) of the IGC-EC; the motion was approved.**

**STRATEGIC PLAN REFRESH**

Kelly Green, Blaine County, provided an update on the Strategic Plan Refresh.

The Strategic Plan Refresh kickoff meeting was held on Wednesday, February 10, 2021. Ms. Green announced 18 members (3 from City Gov'ts, 5 Members from Academia, 2 from County Gov'ts, 8 from State Agencies).

The committee formed three sub-committees:

- SC#1 will be researching and learning from the GIS strategic plans of other states and other local and Federal gov't entities. Ms. Green will be leading this subcommittee.
- SC#2 will work on developing a GIS maturity model and assessment to use across the State. Ms. Lewis will be leading this subcommittee.
- SC#3 will be documenting and assessing progress from prior Idaho GIS Strategic Plans and will be headed by Jacqueline Malloy.

Ms. Green outlined the committee's timeline. She stated that the committee will work toward having an initial draft no later than Aug 27, 2021, and final draft no later than September 30, 2021. The group will present the final draft to the IGC-EC at the October meeting and respond to comments and suggested changes no later than mid-Nov 2021. Lastly, they plan on taking the Strategic Plan Refresh to the ITA for approval and adoption in December.

### **TIM NOMINATION SIMPLIFICATION**

Chair Robertson called for a motion to approve updates to ITA Policy P5030 (Framework Standards Development).

### **TRAILS STANDARD AND NOMINATION**

Chair Robertson called for a motion to approve Idaho Trails Data Exchange Standard S4245.

**MOTION: Mr. Weber moved, and Ms. Bond seconded a motion to approve Idaho Trails Data Exchange Standard S4245; the motion was approved.**

Chair Robertson called for a motion to approve the Idaho Trails Nomination.

**MOTION: Ms. Green moved, and Mr. Weber seconded a motion to approve the Idaho Trails Nomination; the motion was approved.**

Mr. Cook highlighted the trails.idaho.gov website and web application receives around 100,000 visitors. Visitors can create their own maps and print into a georeferenced pdf. The georeferenced pdf can be use on smartphones. It is a great resource to help people get outside and use the trails.

### **TECHNICAL WORKING GROUP UPDATES**

#### **GEODETTIC TWG**

Keith Weber, Idaho State University, presented on the Multi-State Control Point Database (MCPD).

Mr. Weber described there are over 21,468 control points (14,263 in Idaho and 7,205 in Montana) in the database currently. Montana created Montana Control Point Database in 2009 and partnered with Idaho in 2012 with FGDC CAP-CG grant.

Mr. Weber clarified all MCPD points are submitted by Professional Licensed Surveyors and go through a rigorous QA/QC submission process. He emphasized the data quality accuracy of +/- 3 cm.

Mr. Weber suggested the MCPD be nominated as a TIM Dataset. Chair Robertson recommended "Example: <http://gis.idaho.gov/portal/pdf/Standards/Themes/XXXXXXXXX.pdf>" be removed from the form. Chair Robertson called for a motion to approve TIM Framework Dataset Nomination.

**MOTION: Ms. Andersen moved, and Ms. Green seconded a motion to approve the MCPD TIM Framework Dataset Nomination; the motion was approved as amended.**

Ms. Green has several survey control points and was wondering what the process was to get them added. Mr. Weber explained the following link could be used for submission.

### **HYDROGRAPHY TWG**

Danielle Bruno-Favreau, Department of Water Resources, gave a Hydrography TWG update.

The Hydrography TWG held a meeting on Thursday, March 11, 2021. This meeting was focused on reviewing the proposed edits to Idaho Falls HU8.

There were four proposed changes:

1. Change HUC12 along the boundary of HUC12.
  - Option 1: Move boundary to the East, the Antelope Creek original boundary.
  - Option 2: Move boundary to the West, would make a new HUC12.**Recommended to move to this Dry Bed. IDWR to recommend to USGS.**
2. Snake River has significantly moved to the west and braiding has changed.
  - Option: Accommodate the changes in the braid by moving the HUC12: 17040203 boundaries to follow the Snake Boundary**IDWR to recommend change in HUC12.**
3. Change near Willow Creek HUC12: 17040201 and 17040206. Original Boundary crosses Snake River
  - Option: Adjust Boundary to not cross the Snake River.**IDWR accepted proposed change by USGS.**
4. HUC boundary based on 3DEP data.  
**Edit was not approved. IDWR to ask for a more refined boundary change.**

- NHDPlus HR-Complete for CONUS! Working on refresh cycle that will officially take the NHDPlus HR out of Beta.

### **BIOSCIENCE**

Angie Schmidt, Dept. of Fish and Game, provided a Bioscience TWG update.

The BioScience kickoff meeting was held on Tuesday, March 16<sup>th</sup> with 11 attendees. The next meeting is scheduled for April 13<sup>th</sup> at 10 am MT.

Four committee members were re-elected: herself to State Seat 2, Cyndi Andersen to Local Seat 5, Shane Lim to Utility Seat 9, and Pam Bond to Open Seat 12. Newly elected members included: Eric Buehler (Federal Seat 3) and Jeff May (Open Seat 11). These terms run April 1, 2021 through March 31, 2023.

Chair Robertson thanked the unelected candidates for their interest in serving.

Chair Robertson called for a motion to adjourn.

**MOTION: Mr. Weber moved, and Ms. Andersen seconded a motion to adjourn; the motion was approved.**
